
Admissions Information for The John Warner School

FOR STUDENTS WISHING TO JOIN YEAR 7 IN SEPTEMBER 2018



Rule 1

Children in Public Care (Looked After Children) or previously looked after

Places are allocated to children in public care according to Part 2, Regulation 7 of the School Admissions (Admission Arrangements and Co-ordination of Admission Arrangements) (England) Regulations 2012. These children will be prioritised under rule 1.

Rule 2

Staff

Children of staff.

Where the member of staff has been employed under contract of employment with the school for two or more years at the time at which the application for admission is made or the member of staff is recruited under a contract of employment to fill a vacant post for which there is a demonstrable skill shortage.

Rule 3

Siblings

Children who have a sibling at the same address who is a pupil at the school at the time of application.

For the purpose of this clause siblings would include sister, brother, half, step, adoptive children provided they also live at the same address.

Rule 4

Distance

Home to School Distance

Home to school distance will be calculated using the Hertfordshire County Council's 'straight line' distance measurement system.

The last person allocated a place under this Rule for the 2017/2018 entry had a home to school distance of 1834.57m.

Rule 5

Technology Aptitude Test

10% of the remaining places will be allocated to children who show an aptitude for technology on the basis of an assessment of aptitude carried out by the school.

Pupils seeking entry to the school on the basis of an aptitude for technology will involve a half day **on 4th October 2017** at the school and will include only those pupils who are seeking a place on this basis.

Deadline for applications is **22nd September 2017**.

Letters regarding the arrangements for the test will be posted home during on **25th September 2017**.

Returning Your Forms

- You **MUST** complete two or three forms:
 - The County Council's online application form by **31st October 2017**
 - The John Warner School's Supplementary Information Form (SIF) in your packs by **31st October 2017**
 - Applications to sit the Technology Aptitude Test **MUST** be received at the school no later than **22nd September 2017**
 - All applications returned after these deadlines will be deemed as "Late"
- SIF Forms must be submitted along with **ALL** of the documentation listed on the reverse of the form.

How Many Rules Can You Choose?

You can choose as many rules as you like.

We would highly recommend that if you are applying under Rule 4 (Distance) that you also consider your child sitting the Technology Aptitude Test (Rule 5).

This will give you a better chance of getting a place at The John Warner School as you will be considered under two separate rules.

Proof of Address

If you are applying under Rule 4 (Distance) then you **MUST** supply us with **ALL** of the documentation listed on the reverse of the form.

We are unable to accept applications without the correct proof of address.

Original documentation can be brought into the school to be photocopied before returning to you or you can send in with a stamped address envelope to be returned to you.
